We are scheduled for training on June 21, 2023. We will have one or two cases which will be ready for review in July.

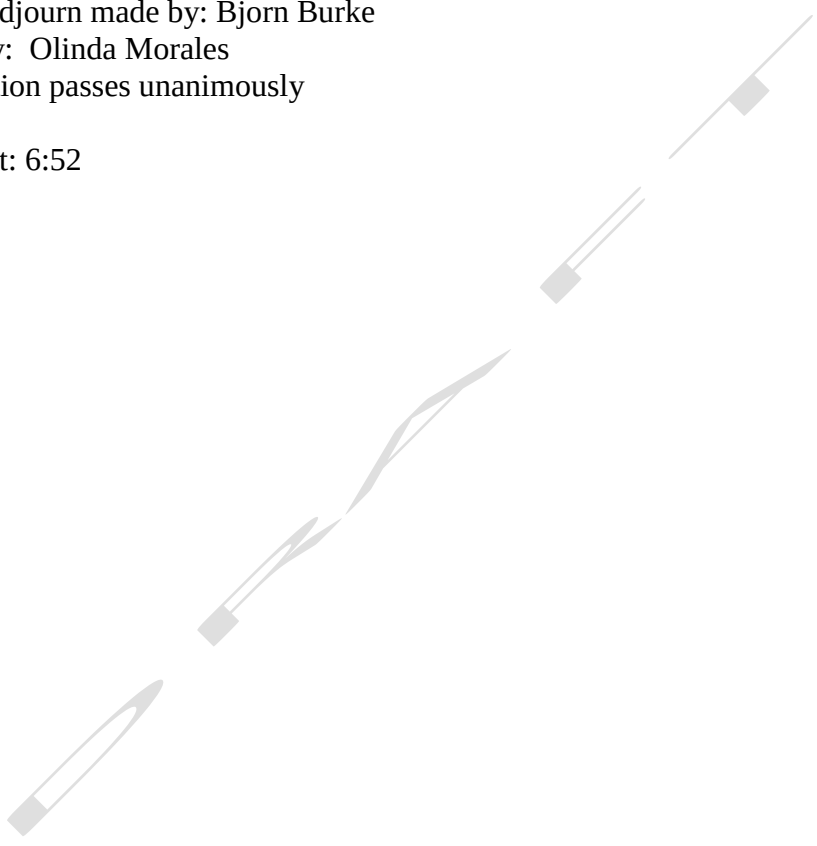
