We are scheduled for our next meeting on July 19, 2023. It is expected that cases will be available to review on that meeting date.

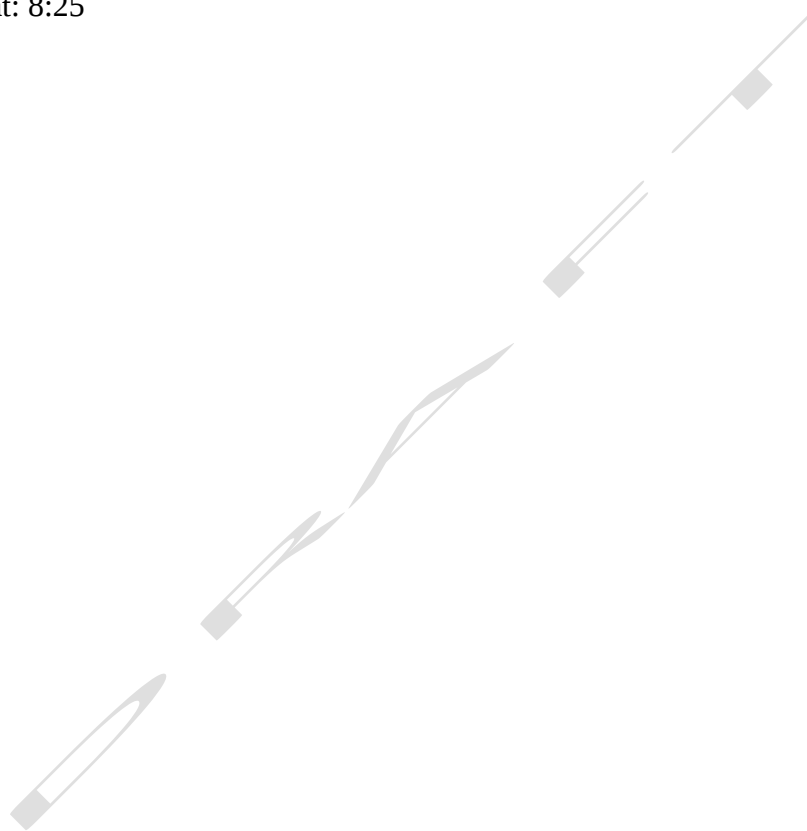
