WEST HARTFORD PUBLIC LIBRARY BOARD MINUTES
Monday, December 1, 2025, 6:30 p.m.

1. CALL TO ORDER

Vice-Chair EJ Greenspan called the Library Board to order at 6:32 p.m. Present were Board members Kim Cohen, Eileen Daly, Natalia Menjivar, Library Director Laura Imscher, and Heidi Reagan, recorder. Member Gail Crockett attended via Zoom link. Present from the public was Kathryn McWilliams.

2. PUBLIC COMMENT – Kathryn McWilliams

- a. Ms. McWilliams told the Board how important the Sunday hours were to her in particular, and the community in general.

5. BUSINESS ITEMS – Laura Imscher

- a. Security at Library Programs and Events
 - i. Consider creating a Library Policy that addresses whether and in what form security measures are included when planning programs and events
 - 1. Concerns that a police presence might be reassuring to some, but a source of challenge and anxiety to others
 - 2. Involve community members, the police department, and Corporation Counsel in these discussions going forward
 - 3. Examine what other libraries are doing in similar circumstances
 - 4. Are we sending a message to the public that controversial programs will be sent to other venues, as has happened in the past?
 - 5. The policy should detail what criteria is being considered when determining whether or not to have a security presence.

 - iii. We will continue to ask the Town for the budget to fund more Sunday hours.

Brigid is also a sometimes unseen, but very important, part of any shifting or weeding project because she sorts, withdraws, and packs up books we are ready to say goodbye to, making way for new books. But that's not all! Brigid is a one-person repair department, gluing spines, re-covering with mylar, and removing the dreaded sand from popular beach reads. Brigid has also helped with countless odd jobs over the years, painting, moving, and generally

being awesome. Brigid's reach is also felt outside of the library as she is a big part of the annual Kindness Project, where she helps sort and package donations made to West Hartford Food Pantry and the Fern Street Backpack Program. Thanks for all you do Brigid!

Community Engagement & Outreach

Ellen and Bailey attended Webster Hill Elementary School's Reading Night on Wednesday 12/3. They made library cards, and gave out plenty of information and goodies as kids spun the wheel to win stickers, pens, bookmarks etc.

The Fern Street Backpack program, led by the Fern Street Universalist Church, began in 2015. At the present time, the program feeds 206 students who pick up food in 14 schools and all three West Hartford Public Libraries. There are no requirements for students who pick up a bag of food weekly. The Fern Street Food Ministry has remained committed to offering all who are food insecure, a compassionate and dignified experience. There are 25 students receiving food bags each week at the Faxon Branch Library, 6 students registered at the Bishops Corner Branch and 2 at the Noah Webster Library.

From Our Patrons

Here are some stories and interactions our staff recently had with patrons at the library:

- We received this really nice email from a patron:

Hello!

I'm a Cheshire patron who visited Noah Webster's stacks for the first time recently, and am writing to express how moved and impressed I was by your Russian-language collection. The sheer size of it alone would communicate a remarkable effort to serve the reading needs of Russian speakers in the community.

But I was even more profoundly moved by the remarkably tight selection of books. It's not just a stack of Russian lit classics in the original - it's a cut across the genres spectrum, from popular page turners to Tolkien in translation; from the best of late-Soviet satirical SF to challenging memoirs of the horrors of early-Soviet history. Did I see multiple biographies of Georgiy Daneliya, or was that my imagination playing tricks?

There isn't a single member of my family who would walk away from Noah Webster with nothing to read. There's Dontsova, Marinina and Nora Roberts for the grandma who'd never be caught without a mass market paperback in her hand. Then there's Zhvanetsky, my grandpa's favorite comedian. Several novellas by my Dad's favorite SFF duo, the Strugatskys. Some Rubina and Coelho for my mom. And Petkevich's two-part memoirs for my interest in the history of the Stalinist purges; talk about a deep cut pick. (I was surprised you had Petkevich's memoirs and not Ginzburg's *Journey into the Whirlwind*, which is more well-known).

I'm so curious about how you went about curating this marvel, because it feels like it was put together by the owner of a Russian-language bookstore; someone who is deeply plugged into the reading interests of the diaspora. Did you interview Russian-language speakers in the community? Was this all an accident because of patrons donating their Russian-language books?

Thanks again for such a thoughtful collection and creating a library environment I'd love to bring my children to one day.

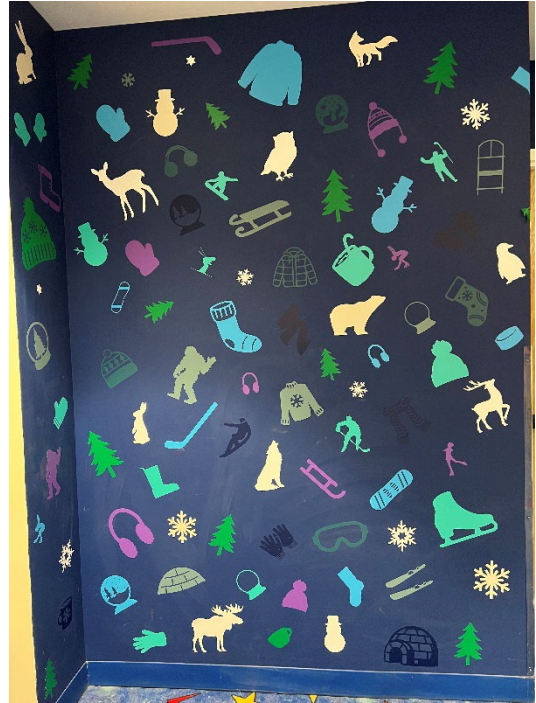
Disco lighting led to dark photographs!

West Hartford Public Library POLICY MANUAL

Title: Vulnerable Child Policy

Revised by the West Hartford Library Board, April 25, 2016.

The West Hartford Public Library encourages children of all ages to enjoy the facilities, programs and collections offered at the Noah Webster, Faxon Branch and Bishops Corner Branch Libraries.

The Library is dedicated to providing a safe and comfortable environment for users of all ages. For the safety and comfort of children, a responsible caregiver must accompany children while they are using the Library.

Caregivers must provide appropriate supervision based upon the ages, abilities and levels of responsibility of their children.

Children under the age of twelve must not be left unattended by a caregiver in any part of the Library building at any time. The assigned caregiver must be responsible for, in the immediate vicinity of and in visual contact with the child. The responsibility for the safety and behavior of children in the library rests with the parent/caregiver and not with the library staff.

The safety of children left alone in a library building is a serious concern. If children are found to be unattended by a caregiver, the Library staff will attempt to locate that person within the building. If this is unsuccessful, the police department will be contacted.

- If, at closing time, children under the age of twelve are found to be without a caregiver present, library staff will attempt to locate the person responsible for the child. If no one is located, the police department will be contacted.
- During story time or other programs when the child attends a program with a library staff member, caregivers must remain on the same floor of the building during that program and be responsible for reuniting with the child at the conclusion of the program.

Caregivers should be aware of the content of the Connecticut General Statute 939, section 53- 21a. regarding "leaving a child unsupervised in a place of public accommodation," upon which this policy is based.
